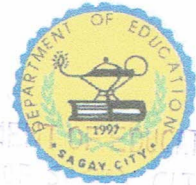

However, travelling expenses of the student contestants, their coaches and the school head shall be charged to school MOOE or other local and allowable sources while that of the EPS's and the OIC SDS shall be charged to the Division MOOE, subject to the usual government accounting and auditing rules and regulations.

The official contestants, their coaches and the EPS's who are part of the regional delegation shall be provided with meals, kits, identification tags, contest materials and other resources needed in the conduct of the 2020 NFOT by the host Region and schools division. The first meal to be served shall be lunch on February 17, 2020 while the last meal shall be A.M. snacks on February 21, 2020.

It is understood that in the conduct of this activity there shall be no discrimination in the provision of such assessment on account of age, school, gender, civil status, disability, religion or other similar factors/personal circumstances that run counter to the principles of equal opportunity.
