1. The Schools Division Office has moved the schedule of Division EsP Virtual Reporting on Quarter 1 Assessment and the giving of Feedback for the Learning Modalities on **January 10, 2022, 1:00 – 5:00 p.m. at Jose B. Puey Elementary School**. Since internet intermittent signal is still prevalent in the locality, this activity will be held in Limited Face-to-Face, and it shall be participated in by the 11 EsP District Coordinators only.
2. This activity still purports to gather reports through face-to-face and online from EsP District Coordinators along with
 - a. Quarter 1 Assessment (EsP MPS & Grades per Grade Level), and
 - b. facilitating and hindering factors in implementing the different blended learning modalities such as Modular, Online, TBI, & RBI, that are further categorized as No-Tech, Low-Tech, Medium-Tech, and High-Tech.
3. It is expected that the 11 EsP District Coordinators shall be able to orally report the forestated and enumerated items.
4. Transportation and internet connectivity expenses incurred by the participants are chargeable against school funds subject to the usual COA rules and regulations.
5. In reiteration, stringent compliance to mandatory health protocols in schools is required of every participant per clustered group such as wearing of masks and face shield, one-meter social distancing inside the room, availability of sanitizers at the door area, temperature checking upon entry of the participants.
6. Immediate and widest dissemination of and strict compliance with this memorandum are desired.
