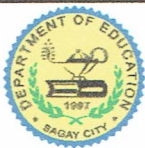

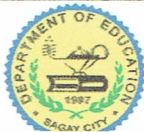

**10<sup>th</sup> ASEAN QUIZ REGIONAL COMPETITION**

**I. Mechanics and Guidelines (Preparations)**

1. The coach/ trainer must register the student-participant using the link to be provided thru AP Group Chat. The registration deadline shall be on January 12, 2022.
2. The 10th ASEAN Quiz Regional Competition shall be conducted virtually using zoom meeting application and or google meet.
3. Each student-participant shall prepare (2) gadgets with functioning cameras with the assistance of their respective school or Schools Division Office. One shall be placed in front of the participant, and one at the back of the participant. All gadgets/ cameras of the participant shall log in to the zoom link or google meet link to be sent to the Division Program Supervisors. All its cameras shall be turned on.
4. Participants display name in all cameras/ gadgets shall be renamed to:
  - Camera 1 (In front of the learner-participant) Display Name: Division\_Camera 1
  - Camera 2 (Back of the learner-participant) Display Name: Division\_Camera 2
5. The participant must face the blank wall in answering and the front gadget's microphone shall be turned on for the entire duration of the events and the back gadget shall be muted to avoid feedback.
6. Each participant must prepare 50 sheets of clean A4 bond papers. Before the start of the quiz proper, each participant shall show to screen each sheet for checking. The participant's division name shall be written on the upper right of the A4 bond papers.
7. The coach must ensure that the place where the participant is located shall be free from all forms of background sounds and noises. This is to ensure that no one is coaching the participant while answering the items. Another is that only to zoom platform/ google meet be open and other tabs or applications be closed.
8. Only one person shall be allowed inside the room where the participant is located. He/ she shall take charge ONLY on the technical issues and concerns.
9. The Schools Division Offices must ensure that there is a stable internet connection during the conduct of the event, aside from the WIFI connections, mobile data shall be prepared as back up in the event that there shall be problems with the internet.
10. In the event that the participant unintentionally left the meeting due to poor internet connection and other technical problems, he/she may resume with the quiz however, questions that have been already asked shall not be repeated.
11. ONLY Correct answers that are acknowledged by the Quiz Master shall be given points.
12. It is expected that SDOs must checked all the gadgets and internet connections prior to the conduct of the event.

**II. Contest Proper**

1. The quiz shall be composed of two segments. As stipulated in the Enclosure No. 3 of DepEd Memorandum No. 76, s. 2021:
  - a. Segment 1: The **True or False** part shall have 10 questions. Each correct answer

2. Each participant shall be provided with a clean A4 size bond paper, and a marker to be used in answering the questions for Segments 1 & 2. Participants will write their answers on the clean A4 bond paper
3. For Segment 1 (True or False and Multiple Choice), Participants shall write the word **TRUE or FALSE** for the True or False questions and write the letter (**CAPITALIZED**) of the correct answer for the multiple choice questions. Participants shall be given 10 seconds to write down their answer.
4. For Segment 2 (Fill in the blanks or Completion), participants shall be given 15 seconds to write down their answer. A buzzer shall indicate that the time is up. Answers should be written in full. With no **ABBREVIATIONS or ACRONYMS**. Articles and prepositions should be correct. Answers with wrong spelling will be considered wrong. Corrections may be made by the participants but the previous answers must be fully erased or fully crossed within the given time allotment.
5. Each question in Segment 1 & 2 will be read twice, after the Quizmaster reads the question the second time he/ she will say “**GO**”, only then shall the participant write their answer. When the time is up the Quizmaster shall say “**MARKERS UP**”. participants shall then hold up their markers and A4 size bond paper to show their answers.
6. The quiz master shall read allowed the answers of each participant. The scores shall record the answers accordingly.
7. A cumulative score per participant shall be announced by the Quizmaster after each round before moving on to the next segment.
8. The Organizing Committee and Sub- Committee on Test Development and Quiz Mechanics shall provide technical support and clarification deemed necessary by Board of Judges.
9. Scoring Systems. There shall be two scoring systems to ensure correctness of tabulations which are: (1) by computer, and (2) manually, using scoring sheets and a tabulation board prominently displayed for the reference of the Student-Participants, The Board of Judges, the Committees, Coaches, and other Guests.
10. After the completion of Segment 2, the cumulative points earned by each participant in the 2 segments shall be tabulated. The results shall be examined and verified by the 10<sup>th</sup> ASEAN Quiz Organizing Committee. When the results have been verified, these will be submitted to the Board of Judges and announced accordingly by the quiz master.
11. The Chairman of the Board of Judges declare the Champion, First Runner- Up, Second Runner- Up, and Third Runner- Up. Winners shall receive Certificate of Recognition, Trophy and Medal. The Champion shall represent Region VI-Western Visayas in the 10<sup>th</sup> ASEAN Quiz Competition, Philippines Quezon City on March 8-11, 2022.
12. In case of a tie, tiebreaker question/s shall be asked until definite winner/ s emerges. At the start of tiebreaker round the scores shall revert to zero.
13. Should there be questions or protests the Board of Judges shall decide on the matter. Their decision is final.
