CONTRACT AGREEMENT


THIS AGREEMENT made the _____ day of 06 MAY 2021 20____ between Department of Education-Division of Sagay City of the Philippines (hereinafter called "the Entity") of the one part and Terpucom Computer Accessories Marketing, Sagay City, Negros Occidental, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly CY 2021 Supply and Delivery of Tablet for Digital Distance Learning and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Nine Hundred Twenty Eight Thousand Five Hundred Pesos (Php 928,500.00) (hereinafter called "the Contract Price").

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. **Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of Nine Hundred Twenty Eight Thousand Five Hundred Pesos (Php 928,500.00) or such other sums as may be ascertained, Terpucom Computer Accessories Marketing agrees to supply and deliver the office supplies in accordance with its Bid.
